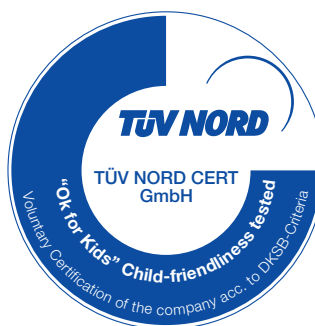
Child-friendliness under scrutiny
